OACDL DUI Seminar BIOGRAPHIES

Alonda Bush is an Assistant Public Defender with the Cuyahoga County Public Defender Office where she handles OVI and other traffic cases. Alonda graduated Cum Laude from the Cleveland-Marshall College of Law in 2016.

T. Douglas Clifford is in private practice focusing on criminal and OVI/DUI defense. Doug is an Ohio Association of Criminal Defense Lawyers board member and CLE co-chair; founding member of the DUI Defense Lawyers Association; National College for DUI Defense member; associate member of the American Academy of Forensic Sciences and member of the American Chemical Society – Chemistry and Law Division. He has achieved ACS-CHAL's Forensic Lawyer-Scientist designation. And he has been trained in the NHTSA Standardized Field Sobriety Testing protocol. Doug received his JD from Case Western Reserve Law School in 2001.

Kenneth A. Bossin is a private practitioner who is certified as an instructor for the NHTSA DWI Detection and Standardized Field Sobriety Testing program. Ken has served as an expert regarding field sobriety tests in an Aggravated Vehicular Homicide and other OVI cases. And he served on the Ohio Sentencing Commission's Traffic Law Subcommittee. Ken is a member of the Ohio Association of Criminal Defense Lawyers, National Association of Criminal Defense Lawyers and National College of DUI Defense. He received his JD from the Cleveland-Marshall College of Law.

Meredith O'Brien is an Associate Attorney at Bailey Legal Group in Sandusky, Ohio. Prior to joining the firm, she was a Public Defender in Cuyahoga County. Meredith is certified in the NHTSA's Standardized Field Sobriety Testing program. She serves on the Ohio Association of Criminal Defense Lawyers' executive committee and is co-chair for CLE. Meredith received her JD from Dequesne University School of Law in 2010. **Joseph Hada** dedicates his practice to OVI/DUI, criminal and traffic defense. He is one of five practicing attorneys in Ohio who has earned the American Chemical Society – Chemistry and Law Division's Forensic Lawyer-Scientist designation. And he completed NHTSA's DWI Detection Standardized Field Sobriety Testing and Advanced Roadside Impaired Driving Enforcement training. Joe was the lead attorney behind ensuring that breath test results from the faulty Intoxilyzer 8000 would be deemed inadmissible in a court of law. He is on the Ohio Association of Criminal Defense Lawyers' Board of Directors. Joe received his JD from Cleveland-Marshall College of Law.

Jeffrey Kakish is an associate attorney at Quinn Legal Associates who dedicates his practice to OVI/DUI, criminal and traffic defense. He began his legal career with the Lake County Public Defender Office where he successfully litigated numerous motion hearings and trials. Jeff was the first Ohio attorney to earn the American Chemical Society – Chemistry and Law Division's Forensic Lawyer-Scientist designation in 2016. Ilg, he helped convince the Ohio Supreme Court that accused citizens have a right to challenge their breath test results. Tim received his JD from Capital Law School.

Officer Ott was responsible for the arrest of over 1700 impaired drivers.
